Outstanding Performance Series

I assume most of you have heard that December 31, 2016, will be my last day to serve as the OPS State Chair. I told the ATSSB State Board of Directors in February, 2016, that after twenty years it is time for someone else to hold the position of OPS State Chair. I also told the board that I would like to present the awards to the 2016 OPS winners and runners-up during the 2017 TMEA Convention, and they agreed.

Since this is my last article, I want to take this opportunity to give the membership an idea of how the Outstanding Performance Series got started, and how it has evolved into the important part of ATSSB that it is today.

It all started on December 16, 1996, when ATSSB President Don Stockton, President-Elect Ronnie Page, Executive Secretary Kenneth Griffin, George Strickland, Eric Wharton, Gene Conway, and I met in my home to discuss the possibility of developing a tape audition program designed to select the most outstanding Class A, AA, & AAA programs in the state. After some discussion, I



was asked if I would serve as the OPS State Chair. I said that I would do it, but I had no idea how to go about it. When everyone left my home that afternoon, I went to my computer and started writing. I wrote and wrote, then called Ronnie and Kenneth, bounced ideas off of them, wrote and rewrote, bounced more ideas off of them, and in time came up with a good place to start. It seems like the more I wrote, the more forms we had to have, the more instructions I had to write, and the more revisions I had to make. To this day I still don't know how I did that! I assure you that it was a team effort between me, Ronnie, and Kenneth.

After months of revisions, finally in July, 1997, we had the first State OPS adjudication session at TBA! The State adjudication was held inside the San Antonio Convention Center. We started back then using cassette tapes and did not start using CDs until 2001. After the State adjudication, I would rush back to Clifton, type all of the information about each winning band that would be put on the OPS CD, get the master made in Dallas, and produce 1000 CDs. I would then combine the OPS CD with the ATSSB All-State Concert and Symphonic band CD, and ATSSB would sell the CD sets for \$15.00. In 2006, a decision was made to quit selling the OPS CDs and start including them in the ATSSB Newsletter that Kenneth mails out every September.

During the first three years, everything was done with no honorarium, but in 2000 the SBOD decided to give an honorarium of \$25.00 to the adjudicators and monitors at the region and area levels. No honorarium was given at the State level until 2003 when the honorarium for all levels went up to \$35.00. The honorarium went up in 2006 to \$60.00, and up again in 2010 to \$75.00 plus \$2.50 for every CD judged over 35 CDs. It remains that way today. Just so you know, in 1997 we had a total of 174 entries, and in 2016 we had 624 entries!

I hope you can understand when I say that I am very proud of the way the Outstanding Performance Series has evolved and has become a very important part of ATSSB. It is important that you know that this was not a oneperson job. The program has been successful due to the efforts of our Region and Area Coordinators and the many directors who have served over the years as adjudicators. It has been a team effort.

I want to thank the Past-Presidents of ATSSB and our current President for asking me to serve as the OPS State Chair. It has been an honor to serve in this capacity for the past twenty years. I especially want to thank our Executive Secretary, Kenneth L. Griffin, for his assistance during my twenty-year term. His ideas and suggestions over the years have been very valuable to the success of the program. I also want to thank Collin Anderson for working with me for the past 15 years at the State adjudication. He served as my computer guru every year and did an outstanding job! I know the Outstanding Performance Series will be in good hands with Collin serving as the State Chair. It is highly likely that 2017 will be the year that all files will be digitally uploaded to a server, and CDs will no longer be used. That is a work in progress, and I am sure Collin will do a fine job with that.

I hope you all continue to enter the OPS competition every year, and I wish you the very best of luck!

Executive Secretary's Column

I hope the ATSSB audition process went well for all of you at the region level and that you are looking forward to Area January 7. When you go to Area, make sure you have paid the \$20 Area fee (most regions collect that and send one check). There are no forms to take. Students selected to State will receive a login from TMEA (through their band director) after Area with which they download the Medical Release (needing signatures and a Notary Public) and a Code of Conduct (2 copies - each needing signatures) that they must bring (signed and notarized!) to registration on Wednesday of the clinic. Be sure you make hotel reservations for your students that make the All-State Band (including the students selected to the 2017 ATSSB All-State Jazz Ensemble), and



that you make housing plans for their Designated Chaperones using the housing worksheet provided before January 9 (see sample in this Newsletter on pages 16-17). One director per room will go online to reserve the rooms for all students and their Designated Chaperones (who must stay at the same hotel as the student they are chaperoning).

I would like to take this opportunity to thank Marilyn Bennett and Angie Liss for their service to ATSSB the last two years as Class 1C/2C and 3A Representatives to the ATSSB State Board of Directors respectively. Also to Jim Cude for his term as President of ATSSB. A State office is a time-consuming but necessary role that they took on their shoulders to keep or Association strong and current in our small schools. They also contributed as members of the Executive Committee as it met to accommodate the needs of students and their directors in the interim between State Board of Director meetings. You will notice that we are proposing splitting the office of 1C/2C Representative into two offices: Class 1C Representative and Class 2C Representative. The proposed Constitutional amendment is located on page 13 of this Newsletter.

You will find a schedule of rehearsals and performances for our All-State groups in this newsletter. Notice that the schedule is subject to change and will be kept up to date at:

Please make an effort not only to thank our Licensees for their support, but also to use their services. These companies have paid a fee and are under contract to use the ATSSB logo and marks on their products. They pay a portion of their receipts to the ATSSB All-State Band Scholarship Fund. Please consider using them before any other companies offering the same or similar products. See the list elsewhere in this Newsletter. Also, be sure to ask anyone selling items at ATSSB activities (region concerts, etc.) if they are official ATSSB Licensees.

Remember that All-State students are required to bring their own wire stands to San Antonio. **Music stands will not be provided** in chair auditions or in rehearsals (TMEA will provide music stands in the Lila Cockrell Theatre and the Hemisfair Ballroom 1 for the concerts on Saturday). It is also recommended that students bring their personal tuners to rehearsals (clinicians have asked for that a number of times in the past).

A reminder about piccolo and E_{b} clarinet: If your flute or clarinet player makes the All-State Band at the Area auditions January 7 and would like to play piccolo (flutes) or E_{b} Soprano Clarinet (clarinets), have them bring these instruments to San Antonio. After regular chair auditions are completed for flute/clarinet, we will hold separate auditions for these two instruments in each band from among those students interested in it that were selected for their respective bands. A notice concerning this policy will be placed in the flute and clarinet packets they will receive at Area this year if they are selected for the All-State Band.

Remember that we will be using the TMEA housing forms and reservation procedures at Area. Look over the Housing Quick Guide from TMEA at www.atssb.org/QuickHousingGuide17. pdf and make yourself familiar with the requirements (it is also in this Newsletter on the last two pages). It is pretty simple, really. If you have a student (or students) make the All-State Band at Area (or already have an All-State Jazz Ensemble student), go to the housing table and get with other directors to fill out a room worksheet, putting four students to a room where possible (TMEA will combine others that are incomplete after Area). Make sure you also put a Designated Chaperone in a room at the bottom of the worksheet for each student listed. Decide who will go online before January 9 to reserve the room, using a credit card to make the reservation (you can pay individually using a school check at checkin). We hope this process goes smoothly for you, but feel free to ask questions at Area if you are uncomfortable with any of the procedures. If you have already made reservations at another hotel and must stay at the Hyatt Regency as a Designated Chaperone, you can cancel the other reservation (there will be no cancellation fee if you reserved the room through the TMEA housing process and you cancel the other reservation by January 20).

We plan to hold our ATSSB Business Session in the Convention Center Stars at Night Ballroom 4 at 1:00 p.m. on Friday, February 10. Elections for Class 1C/2C and Class 3A Representatives to the State Board of Directors as well as President-Elect will be held at this meeting. We will also vote on an amendment to the Constitution (see elsewhere in this Newsletter). I hope you can make plans to attend this year. Remember that proxies are not allowed in these elections. A short biographical sketch and picture of each candidate for state office who has submitted documentation can be found in this Newsletter. If any are missing, check back because biographies and/or pictures will be added if and when the candidates have submitted the information to this office.

When you get a chance, be sure to thank our Region and Area Coordinators for their efforts in securing audition sites, hosts, audition chairmen, computer equipment and logistics, etc. Also, let's not forget to thank our State Chair Audition Coordinator (Eric Gray of Gilmer) and all of his helpers and judging panels in advance of the work facing them as the two bands are seated; also Collin Anderson from Groesbeck for serving in the State Chair Auditions Office this year. Our All-State Symphonic Band Organizers (Jason Smith, North Lamar), All-State Symphonic Band Percussion Organizer (Connor Pickle, Melissa), All-State Concert Band Organizer (Arthur Galope, Caddo Mills), All-State Concert Band Percussion Organizer (Sauileoge To'afa, Quinlan), Apprentice Organizer (Justin Wallis, Anna) and All-State Jazz Ensemble Organizer (Marty Filip, Quinlan Ford) still have a job ahead of them. The convention-clinic and concerts will take a

LOT of preparation, advanced planning and organization. Rehearsal and performance space has been arranged for all three organizations, chair audition rooms arranged with screens, tables and chairs before chair auditions begin on Wednesday night, programs have to be completed, badges for the students have to be secured and sorted, not to mention many other activities taking place in the background as we prepare for the clinic. All of the people involved give so much of their time to make it a success. It would not be possible if it weren't for their dedication to the profession and the students in the All-State Bands who benefit from their efforts. Everyone associated with the audition process owes a great deal of gratitude to TMEA Deputy Director Frank Coachman for his untiring efforts on behalf of all Texas musicians. He has been an invaluable friend to ATSSB for many years now. We are all fortunate to have him as a colleague and friend as we strive to better our students musically.

Since this will be our last communication before San Antonio, let me address those of you who will have students in the All-State Band for the first time. Please remember that many are in the "big city" for the first time. They will need frequent contact with you to allay their fears and keep them focused on their role as they represent not only ATSSB, but also their bands, school and community. Drop by rehearsals often, especially at breaks, to see that they have a place to go and that they know what they may do in their free time. It also helps to have directors observing rehearsals at all times. Not only do we learn good rehearsal techniques from our fine clinicians, but also we can act as a restraining presence to students who might otherwise allow their attention to drift during rehearsals. There is certainly nothing wrong with leaning over a student with a cap on and quietly asking him or her to remove it - or watching a section and noticing a student talking in a distracting manner and quietly asking them to stop. Our Organizers are with the band almost constantly, but we cannot expect them to be there every minute nor expect them to see every infraction of rehearsal protocol. Try to drop by and give a listen - and a hand.

Our corporate supporters are so consistent in their desire to help provide shoulder patches and "breakout" refreshments for the all-state students. They will be recognized in the all-state programs, but I just wanted to say an additional "Thank You" to them in advance for their contributions to the continued success of the ATSSB All-State Band. The Elmer and Anita Schenk Family Trust has made a sizeable donation to ATSSB that is now in a brokerage account from which earnings provide the all-state programs each year. Thank you, Founding Charter Member Elmer Schenk, for your thoughtful gift to ATSSB.

Be sure to visit with your Region Coordinators about issues you wish addressed at the State Board meeting coming up. Make your opinions about issues confronting ATSSB known to your representatives to the State Board so they can be discussed with a consensus from the membership.

My thanks to all of you for your continued diligence and hard work on behalf of the students in our small school programs. Keep up the great work.

President-Elect and Class 1C/2C and Class 3A Representatives to the State Board of Directors for 2017-19 will be elected in the ATSSB General Session on Friday, February 12, 2016 at 1:00 in CC Stars at Night Ballroom 4 (check the convention program to be sure of the meeting room and times which may change as the convention approaches). Nominees who submitted a biography and/or picture by the time of publication follow below. Only current Retired and Active Members actively involved in 3A high schools (including their junior high directors) may vote on 3A Representative. Current Retired and Active Members actively involved in junior high schools may vote on 1C/2C Representative. Any current Active or Retired Member may vote on President-Elect. Should nominees send biographies and/or pictures, they will be added as soon as possible and this Newsletter updated online.

Class 1C/2C Representative

Marilyn Bennett is the director at Olney Middle School. She also serves as Associate Band Director and woodwind specialist for Olney ISD. Completing twentynine years of public school teaching, Mrs. Bennett has previously taught in the Palacios, Munday, Holliday, and Dalhart (Texas) school systems as assistant band director, woodwind specialist, and elementary music specialist.

While teaching in Olney, her bands have received numerous honors, including Sweepstakes Awards for concert season and a 2016 TMEA Honor Band finalist distinction.

The Pride of Olney High School has been Area marching band finalist three times (2011, 2013, 2015) and was named a finalist at the 2013 State Marching Band Contest.



The Purple Cloud Band was a state finalist in

the State Marching Contest numerous times, finalist in the TMEA Honor Band Competition, and was named a finalist several times in the ATSSB Outstanding Performance Series. The Munday High School Band also received the distinction of being named the 1994 and

2000 TMEA Class A Honor Band. Under her direction, the second varsity band at MHS received excellent ratings, as did the Munday Middle School Band.

> Mrs. Bennett is a member of Phi Beta Mu International (Alpha Chapter), Texas Music Educators Association, Texas Bandmasters Association, National Band Association, Association of Texas Small School Bands (currently serving as Class C/CC Representative), American School Band Directors Association (inducted June, 2016), Women Band Directors International (President 2016-2018), Pi Kappa Lambda, Mu Phi Epsilon, Music Educators National Conference, and Fellowship of Christian Musicians. She has also been a member of the Texana Community Band (Edna), Etesian Winds, North Texas Directors Band, the North Texas Church Orchestra, and the Falls Chamber Orchestra. She is also a life member of Tau Beta Sigma and the Tri-M Music Honor Society.

Mrs. Bennett served as a member of the State Board of Directors of TMEA for sixteen years, Regions II and XIII Secretary, Region II North Zone Secretary, and as secretary to the TMEA Regions II and XII Band Division Chairmen. She has also served Regions II and XIII as secretary to the ATSSB Region Coordinator. In addition, Mrs. Bennett served as Region XIII Junior High Region Band Coordinator and clinic host for various district and region events.

Proposed Constitutional Amendment

Amend Article V, Section 4 from:

AT-LARGE REPRESENTATIVES. One representative from each Class (1C/2C, 1A/2A, 3A, and 4A) shall assume office in the manner prescribed in the By-Laws. Each of the four representatives shall be voting members of the State Board of Directors.

to:

AT-LARGE REPRESENTATIVES. One representative from each Class (1C/2C, 2C, 1A/2A, 3A, and 4A) shall assume office in the manner prescribed in the By-Laws. Each of the four *five* representatives shall be voting members of the State Board of Directors.

Amend Article II, Section 4.(a). of the BY-LAWS from:

DUTIES OF THE AT-LARGE REPRESENTATIVES. Each of the *four five* At-Large Representatives (one from Class *C/CC 1C, one from Class 2C*, one from Class 1A/2A, one from Class 3A, and one from Class 4A) shall serve as voting members of the State Board of Directors so as to maintain a balance of opinion among the different classes of schools.

Amend Article II, Section 3\4.(c). of the BY-LAWS from:

SELECTION. The general membership of ATSSB shall vote by secret ballot in the Business Session on At-Large Representatives. If there is no clear majority, the winner is the candidate with the most votes, provided the runnerup has a shortfall from 50% that is at least double that of the leading candidate; if there is no such candidate, then a secret ballot will be cast between the top two with the individual receiving a simple majority of the total votes cast being declared the winner. Only Active Members who are involved with Class 1C or 2C schools may vote on the Class 1C/2C At-Large Representative, only Active Members who are involved with Class 1A or 2A schools may vote on the Class 3A At-Large Representative, and only Active Members who are involved with Class 4A schools may vote on the Class 4A At-Large Representative. Class 1A/2A and Class 4A Representatives shall be elected in even-numbered years; Class 1C/2C and Class 3A Representatives shall be elected in odd-numbered years. Retired Active Members may vote on the Class Representatives of their choice. Proxy voting is not allowed in the election of At-Large Representatives.

to:

SELECTION. The general membership of ATSSB shall vote by secret ballot in the Business Session on At-Large Representatives. Only Active Members who are involved with Class 1C or 2C schools may vote on the Class $\frac{1C}{2C}$ *IC* At-Large Representative, only Active Members who are involved with Class $\frac{1C}{2C}$ *C* At-Large Representative, only Active Members who are involved with Class 1A or 2A schools may vote on the Class $\frac{1A}{2A}$ At-Large Representative, and only Active Members who are involved with Class 4A schools may vote on the Class 4A At-Large Representative. *Class 1C*, Class 1A/2A and Class 4A Representatives shall be elected in even-numbered years; Class $\frac{1C}{2C}$ and Class 3A Representatives shall

be elected in odd-numbered years. Retired Active Members may vote on the Class Representatives of their choice. Proxy voting is not allowed in the election of At-Large Representatives.

Amend Article II, Section 5.(q). of the BY-LAWS from:

SECTION 5.(a). THE STATE BOARD OF DIRECTORS. The State Board of Directors shall be composed of all Founding Members, current Region Coordinators, the President, the President-Elect, the Immediate Past-President, the Executive Secretary, and the four At-Large Representatives, each of whom must be a member in good standing for the current year.

to:

SECTION 5.(a). THE STATE BOARD OF DIRECTORS. The State Board of Directors shall be composed of all Founding Members, current Region Coordinators, the President, the President-Elect, the Immediate Past-President, the Executive Secretary, and the *four five* At-Large Representatives, each of whom must be a member in good standing for the current year.

Rationale: Here are the numbers of participating schools in ATSSB 2015-16:

1C = 1592C = 1551A = 592A = 1533A = 2084A = 175

If you combine the 1C/2C and the 1A/2A (like we do now for the Executive Committee), you get: 1C/2C = 314

1A/2A = 2123A = 2084A = 175

With a separate Representative for 1C and 2C (leaving 1A/2A together), we would have:

1C = 1592C = 1551A/2A = 2123A = 2084A = 175

This would give us 9 on the Executive Committee, which would make voting better proportionately (if the President does not vote except in a tie, then matters could be resolved more equitably; right now, it is possible for a matter to pass the Executive Committee without Presidential input even if contested because only 7 can vote unless there is a tie - and their can not be a tie with 7). Also, we already separate 1C and 2C in OPS and have done so since 1998. The only reason there is 1A/2A is that UIL wanted to separate 6-man schools from the others.
