#### **Executive Secretary's Column** by Kenneth L. Griffin

I hope the ATSSB audition process went well for all of you at the region level and that you are looking forward to Area January 11. When you go to Area, make sure you have paid the \$25 Area fee (most regions collect that and send one check).

There are no forms to take to Area. Students selected to State will receive a login from TMEA (through their band director) after Area with which they download the Medical Release (needing signatures and a Notary Public) and a Code of Conduct (needing signatures) that they must bring to registration on Wednesday of the clinic. Be sure you make hotel reservations for your students that make the All-State Band (including the students selected to the 2020 ATSSB All-State Jazz Ensemble), and that you make housing plans for their Designated Chaperones using the housing worksheet provided before January 13 (see sample in this Newsletter on pages 24-25). One director per room will go online to reserve the rooms for



pages 24-25). One director per room will go online to reserve the rooms for all students and their Designated Chaperones (who must stay at the same hotel as the student they are chaperoning).

I would like to take this opportunity to thank Christina Smith for her service to ATSSB the last two years as Class 2C Representative to the ATSSB State Board of Directors and to Jason Smith for his service to ATSSB the last two years as Class 4A Representative. We appreciate the service of Brandon Garmon who was appointed to complete the term of Class 1A/2A Representative. A State office is a time-consuming but necessary role to keep or Association strong and current in our small schools. They also contributed as members of the Executive Committee as it met to accommodate the needs of students and their directors in the interim between State Board of Director meetings.

You will find a schedule of rehearsals and performances for our All-State groups in this newsletter. Notice that the schedule is subject to change and will be kept up to date at:

Please make an effort not only to thank our Licensees for their support, but also to use their services. These companies have paid a fee and are under contract to use the ATSSB logo and marks on their products. They pay a portion of their receipts to the ATSSB All-State Band Scholarship Fund. Please consider using them before any other companies offering the same or similar products. See the list elsewhere in this Newsletter. Also, be sure to ask anyone selling items at ATSSB activities (region concerts, etc.) if they are official ATSSB Licensees. This brings up a point regarding recorded examples of ATSSB audition music. The only officially approved recordings are those by Licensees. We realize some college and university faculty members make recordings, but you need to be careful they do not use their own editions or interpretations utilizing individual editorial changes that might confuse the student when auditioning. Check to be sure the recordings are provided by official ATSSB Licensees before purchasing them. Not only will you be maintaining consistent recording and performing standards, you will also be supporting our Scholarship Fund since Licensees pay a royalty on all sales to the Fund.

Remember that All-State students are required to bring their own wire stands to San Antonio. **Music stands will not be provided** in chair auditions or in rehearsals (TMEA will provide music stands in the Lila Cockrell Theatre and the Hemisfair Ballroom 1 for the concerts on Saturday). It is also recommended that students bring their personal tuners to rehearsals (clinicians have asked for that a number of times in the past). Our Band Organizers will have a limited number of wire stands for sale

prior to auditions and at rehearsals.

A reminder about piccolo and  $E_{\flat}$  clarinet: If your flute player makes the All-State Band at the Area auditions January 11 and would like to play piccolo, have them bring their piccolo to San Antonio. After regular chair auditions are completed for flute, we will hold separate auditions for piccolo in each band from among those students interested in it that were selected for their respective bands. The Symphonic Band will not have an  $E_{\flat}$  clarinet part on any of the music programmed, so that instrument will not be auditioned at State this year. But if your clarinet player makes the 3A All-State Band at the Area auditions January 11 and would like to play  $E_{\flat}$  clarinet, have them bring their  $E_{\flat}$  clarinet to San Antonio. After regular chair auditions are completed for clarinet, we will hold separate auditions for  $E_{\flat}$  clarinet in the 3A Concert Band from among those students interested in it that were selected for the 3A All-State Concert Band on clarinet. A notice concerning this policy will be placed in the flute and clarinet links they will receive at Area this year if they are selected for the All-State Band. Piccolos and soprano clarinet players will audition on the actual piccolo or soprano clarinet parts and that chair placement in their respective bands will have nothing to do with who is selected to play piccolo or  $E_{\flat}$  clarinet.

Remember that we will be using the TMEA housing forms and reservation procedures at Area. Look over the Housing Quick Guide from TMEA at https://www.atssb.org/files/AREA/ HousingQuickGuide2020.pdf and make yourself familiar with the requirements (it is also in this Newsletter on pages 24-25). It is pretty simple, really. If you have a student (or students) make the All-State Band at Area (or already have an All-State Jazz Ensemble student), go to the housing table and get with other directors to fill out a room worksheet, putting four students to a room where possible (TMEA will combine others that are incomplete after Area). Make sure you also put a Designated Chaperone in a room at the bottom of the worksheet for each student listed. Decide who will go online before January 15 to reserve the room, using a credit card to make the reservation (you can pay individually using a school check at checkin). We hope this process goes smoothly for you, but feel free to ask questions at Area if you are uncomfortable with any of the procedures. If you have already made reservations at another hotel and must stay at the Hyatt Regency as a Designated Chaperone, you can cancel the other reservation (there will be no cancellation fee if you reserved the room through the TMEA housing process and you cancel the other reservation by January 25).

We plan to hold our ATSSB Business Session in room CC225 of the Convention Center at 1:00 p.m. on Friday, February 14. Elections for Class 2C, Class 1A/2A and Class 4A Representatives to the State Board of Directors will be held at this meeting. I hope you can make plans to attend this year. Remember that proxies are not allowed in these elections. A short biographical sketch and picture of each candidate for state office who has submitted documentation can be found in this Newsletter. If any are missing, check back because biographies and/or pictures will be added if and when the candidates have submitted the information to this office.

When you get a chance, be sure to thank our Region and Area Coordinators for their efforts in securing audition sites, hosts, audition chairmen, computer equipment and logistics, etc. Also, let's not forget to thank our State Chair Audition Coordinator (Eric Gray of Gilmer) and all of his helpers and judging panels in advance of the work facing them as the two bands are seated; also Collin Anderson from Groesbeck for serving in the State Chair Auditions Office this year. Our All-State Symphonic Band Organizers (Brian Sours, Tenaha), All-State Symphonic Band Percussion Organizer (Brian Straw, Henderson), All-State Concert Band Organizer (Luis Zepeda, London), All-State Concert Band Percussion Organizer (David Speer, New Deal), Apprentice Organizer (Justin

Ketner, Winona), Apprentice Percussion Organizer (Jordan Fitzwater, Community) and All-State Jazz Ensemble Organizer (Benjamin Keltner, Port Isabel) still have a job ahead of them. The conventionclinic and concerts will take a LOT of preparation, advanced planning and organization. Rehearsal and performance space has been arranged for all three organizations, chair audition rooms arranged with screens, tables and chairs before chair auditions begin on Wednesday night, programs have to be completed, badges for the students have to be secured and sorted, not to mention many other activities taking place in the background as we prepare for the clinic. All of the people involved give so much of their time to make it a success. It would not be possible if it weren't for their dedication to the profession and the students in the All-State Bands who benefit from their efforts. Everyone associated with the audition process owes a great deal of gratitude to TMEA Deputy Director Frank Coachman for his untiring efforts on behalf of all Texas musicians. He has been an invaluable friend to ATSSB for many years now. We are all fortunate to have him as a colleague and friend as we strive to better our students musically. We also appreciate Andrew Denman, TMEA Information Technologist, for his efforts to keep the audition tabulation software in top form.

Since this will be our last communication before San Antonio, let me address those of you who will have students in the All-State Band for the first time. Please remember that many are in the "big city" for the first time. They will need frequent contact with you to allay their fears and keep them focused on their role as they represent not only ATSSB, but also their bands, school and community. Drop by rehearsals often, especially at breaks, to see that they have a place to go and that they know what they may do in their free time. It also helps to have directors observing rehearsals at all times. Not only do we learn good rehearsal techniques from our fine clinicians, but also we can act as a restraining presence to students who might otherwise allow their attention to drift during rehearsals. There is certainly nothing wrong with leaning over a student with a cap on and quietly asking him or her to remove it - or watching a section and noticing a student talking in a distracting manner and quietly asking them to stop. Our Organizers are with the band almost constantly, but we cannot expect them to be there every minute nor expect them to see every infraction of rehearsal protocol. Try to drop by and give a listen - and a hand.

Our corporate supporters are so consistent in their desire to help provide shoulder patches and "breakout" refreshments for the all-state students. They will be recognized in the all-state programs, but I just wanted to say an additional "Thank You" to them in advance for their contributions to the continued success of the ATSSB All-State Band. The Elmer and Anita Schenk Family Trust made a sizeable donation to ATSSB a number of years ago that is now in a brokerage account from which earnings provide the all-state programs each year. Thank you, Founding Charter Member Elmer Schenk, for your thoughtful gift to ATSSB.

Be sure to visit with your Region Coordinators about issues you wish addressed at the State Board meeting coming up. Make your opinions about issues confronting ATSSB known to your representatives to the State Board so they can be discussed with a consensus from the membership.

Thanks to all of you for your continued diligence and hard work on behalf of the students in our small school programs. Keep up the great work.

The irony of the statement is that reflecting, planning, and communicating (going slower and thinking) will help things move faster. If you don't have time to do it right, when will you have time to do it over? I say this for myself as well, take some time to think and reflect (good things and had) to halp things go batter for the appreciation.



take some time to think and reflect (good things and bad) to help things go better for the next season.

Relationships during stressful times can sometimes get frayed. Parents, colleagues, students, administration, spouses and significant others are very important to us. At this point in the year, look around and examine those relationships. How are they? Healthy and positive or stressed and shaky? Continue to nurture the healthy ones and see what you can do to repair the frayed ones. The relationships around us are what makes our programs successful. Do not let them get frayed, worn, or taken for granted. During the fall, we move so fast and forget to take the time to listen and value, the relationships around us: with colleagues, our home families, and band families. Those relationships we know we have stressed, take a moment to help rebuild and express the value to them that they are to you.

Life is not all about band. Yes, we teach life through band, but when your life becomes band, burning out and bad attitudes can easily happen. Your enthusiasm, vigor, and excitement is what can motivate and encourage the surrounding people.. Find ways to reinvigorate your passion for music and teaching. Inspiration can come from many places: recharging your batteries, resetting your approach, forgiving yourself and others – whatever you want to call it – go find what works to bring that fervor back into your class every day.

Daily drills, rehearsal techniques, recording your rehearsals, planning rehearsals, new teaching strategies are well and good. I tell our students, music is a simple concept; know what note to play and know how long to play it; then put the icing on the cake. The difference is always in the details but don't get lost in them. We teach the greatest subject, with the best students in the greatest state. Reflect on what you are doing – keeping the good and fixing the bad; rebuild those important relationships around you – keeping the good and fixing the bad; and reinvigorate your passion – by

keeping the good and fixing the bad. Have a great holiday season!

simple majority of the total votes cast being declared the winner.

Amend Article II of the By-Laws from:

**SECTION 4.(b). AT-LARGE REPRESENTATIVE TERM OF OFFICE.** The At-Large Representatives shall serve a term of two years. The term shall begin immediately upon election and shall last until successors are duly elected.

**SECTION 4.(c). ELECTION.** The general membership of ATSSB shall vote by secret ballot in the Business Session on At- Large Representatives. If there is no clear majority, the winner is the candidate with the most votes, provided the runner-up has a shortfall from 50% that is at least double that of the leading candidate; if there is no such candidate, then a secret ballot will be cast between the top two with the individual receiving a simple majority of the total votes cast being declared the winner. Only Active Members who are involved with Class 1C schools may vote on the Class 1C At-Large Representative, only Active Members who are involved with Class 2C schools may vote on the Class 2C At-Large Representative, only Active Members who are involved with Class 3A achools may vote on the Class 1A/2A At-Large Representative, only Active Members who are involved with Class 3A At-Large Representative, and only Active Members who are involved with Class 4A schools may vote on the Class 2C, Class 1A/2A and Class 4A Representatives shall be elected in even-numbered years; Class 1C and Class 3A Representatives shall be elected in odd- numbered years. Retired Active Members may vote on the Class Representatives of their choice. Proxy voting is not allowed in the election of At-Large Representatives.

SECTION 4.(d). VACANCY IN OFFICE. In the event of a vacancy of an At-Large Representative for any reason, the President shall appoint a replacement to fill the unexpired term.

#### To:

**SECTION 4.(b).** NOMINATION. At the Spring or Fall Region Meeting of odd years, each Region may submit one name for the office of Class 2C Representative, one name for the office of Class 1A/2A Representative, and one name for Class 4A Representative to be nominated for election at the forthcoming Clinic/Convention. At the Spring or Fall Meeting of even years, each Region may submit one name for the office of Class 1C Representative and one name for 3A Representative to be nominated for election at the forthcoming Clinic/Convention. The presiding officer of each Region shall file the name of the candidate with the Executive Secretary. The Executive Secretary shall notify each candidate of their nomination. If the nominated candidate does not accept the nomination by December 1 by submitting a biography and picture for the December Newsletter, the name(s) will be deleted from the list of candidates. Nominations for the office may be made from the floor.

**SECTION 4.**(*c*). **AT-LARGE REPRESENTATIVE TERM OF OFFICE.** The At-Large Representatives shall serve a term of two years. The term shall begin immediately upon election and shall last until successors are duly elected.

**SECTION 4.(***d***). ELECTION.** The general membership of ATSSB shall vote by secret ballot in the Business Session on At- Large Representatives. If there is no clear majority, the winner is the candidate with the most votes, provided the runner-up has a shortfall from 50% that is at least double that of the leading candidate; if there is no such candidate, then a secret ballot will be cast between the top two with the individual receiving a simple majority of the total votes cast being declared the winner. Only Active Members who are involved with Class 1C schools may vote on the Class 1C At-Large Representative, only Active Members who are involved with Class 2C schools may vote on the Class 2C At-Large Representative, only Active Members who are involved with Class 3A schools may vote on the Class 1A/2A At-Large Representative, only Active Members who are involved with Class 3A schools may vote on the Class 2C, Class 1A/2A and only Active Members who are involved with Class 4A schools may vote on the Class 3A Representative. Class 2C, Class 1A/2A and Class 4A Representatives shall be elected in even-numbered years; Class 1C and Class 3A Representatives shall be elected in odd- numbered years. Retired Active Members may vote on the Class Representatives of their choice. Proxy voting is not allowed in the election of At-Large Representatives.

SECTION 4.(e). VACANCY IN OFFICE. In the event of a vacancy of an At-Large Representative for any reason, the President shall appoint a replacement to fill the unexpired term.

Rationale: There needs to be a clear nominating procedure for each state office.

## **ELECTION**

Class 2C, Class 1A/2A and Class 4A Representatives to the State Board of Directors will be elected in the ATSSB General Session on Friday, February 14, 2020 at 1:00 in Room CC225 of the Convention Center (check the convention program to be sure of the meeting room and times which may change as the convention approaches). Nominees who submitted a biography and/or picture by the time of publication follow below. Only current Retired and Active Members actively involved in 2C middle schools (including the high directors involved) may vote on 2C Representative. Only current Retired and Active Members actively involved in Class 1A or 2A high schools may vote on 1A/2A Representative. Only current Retired and Active Members actively involved in Class 4A high schools may vote on 4A Representative.
