Executive Secretary's Column by Kenneth L. Griffin

I hope the virtual audition process went well for all of you at the region level and that your students who advanced to Area are preparing for an even better audition file for Area January 9. When you upload your audition file to Area, make sure you have paid the \$25 Area fee (most regions collect that and send one check).

As you may know by now, ATSSB is planning on holding the All-State Clinic-Concert in Melissa June 9-12-2021. Composer Brian Balmages is under contract for the Symphonic Band (and is completing a composition for the band commissioned by ATSSB). Don Lefevre (West Texas A&M University) is under contract for the Concert Band and Dr. Mo Trout (Purdue University) has agreed to be the clinician for the All-State Jazz Ensemble.



There are no forms needed for Area. Students selected to State will receive an email regarding housing in the McKinney Sheraton Hotel and the McKinney Marriott Spring Hill Suites, the Medical Release (needing signatures and a Notary Public) and a Code of Conduct (needing signatures) that they must bring to registration on Wednesday of the clinic June 9, 2021. Be sure you make hotel reservations for your students that make the All-State Band (including the students selected to the 2021 ATSSB All-State Jazz Ensemble), and that you make housing plans for their Designated Chaperones using the housing request that will be sent to all participating directors and students selected to All-State. Designate Chaperones must stay at the same hotel as the student they are chaperoning.

I would like to take this opportunity to thank Gina Muela for her service to ATSSB the last two years as Class 1C Representative to the ATSSB State Board of Directors and to Angie Liss for her service to ATSSB the last two years as Class 3A Representative. Eric Gray will continue to serve as President until the end of the All-State Clinic-Concert June 12, when Matt Knight will assume the office of President. A State office is a time-consuming but necessary role to keep or Association strong and current for our small schools. These outgoing officers also contributed as members of the Executive Committee as it met to accommodate the needs of students and their directors in the interim between State Board of Director meetings.

Please make an effort not only to thank our Licensees for their support, but also to use their services. These companies have paid a fee and are under contract to use the ATSSB logo and marks on their products. They pay a portion of their receipts to the ATSSB All-State Band Scholarship Fund. Please consider using them before any other companies offering the same or similar products. See the list elsewhere in this Newsletter. Also, be sure to ask anyone selling items at ATSSB activities (region concerts, etc.) if they are official ATSSB Licensees. This brings up a point regarding recorded examples of ATSSB audition music. The only officially approved recordings are those by Licensees. We realize some college and university faculty members make recordings, but you need to be careful they do not use their own editions or interpretations utilizing individual editorial changes that might confuse the student when auditioning. Check to be sure the recordings are provided by official ATSSB Licensees before purchasing them. Not only will you be maintaining consistent recording and performing standards, you will also be supporting our Scholarship Fund since Licensees pay a royalty on all sales to the Fund.

After students have been selected for the ATSSB All-State Band, they will receive communication regarding the clinic-concert June 9-12, 2021, asking for a commitment regarding attendance at this activity. Hotel reservation must be made by February 1, 2021, so quick decisions must be made for months in advance. Everyone understands that, should the governor of Texas or the local county judge restrict assemblies to 50 or less due to the pandemic, the clinic will be cancelled and all deposits returned with no penalty.

A reminder about piccolo and E_{\flat} clarinet: If your flute player makes the All-State Band at the Area auditions January 10 and would like to play piccolo, have them bring their piccolo to Melissa. After regular chair auditions are completed for flute, we will hold separate auditions for piccolo in each band from among those students interested in it that were selected for their respective bands. If your clarinet player makes the All-State Band at the Area auditions January 10 and would like to play E_{\flat} clarinet, have them bring their E_{\flat} clarinet to Melissa. After regular chair auditions are completed for clarinet, we will hold separate auditions for E_{\flat} clarinet in each band from among those students interested in it that were selected for clarinet in their respective bands. A notice concerning this policy will be placed in the flute and clarinet links they will receive at Area this year if they are selected for the All-State Band. Piccolos and soprano clarinet players will audition on the actual piccolo or soprano clarinet parts and chair placement in their respective bands will have nothing to do with who is selected to play piccolo or E_{\flat} clarinet.

Much more information will be available online and in the March Newsletter - and even in the June Newsletter - as we approach the All-State Clinic.

We plan to hold our ATSSB Business Session virtually via ZOOM in February (day and time TBA). Elections for President-Elect, Class 1C and Class 3A Representatives to the State Board of Directors will be held via email in the first week of January, and if no one received the majority of votes in that ballot, a runoff will be held between the top two vote-recipients in the first week of February via email, with the winners announced at the General Session (and online after that). A short biographical sketch and picture of each candidate for state office who has submitted documentation can be found in this Newsletter. If any are missing, check back because biographies and/or pictures will be added if and when the candidates have submitted the information to this office.

When you get a chance, be sure to thank our Region and Area Coordinators for their efforts in securing virtual audition panels, etc. Everyone associated with the audition process owes a great deal of gratitude to TMEA Deputy Director Frank Coachman for his untiring efforts on behalf of all Texas musicians. We also appreciate Andrew Denman, TMEA Information Technologist, for his efforts to keep the audition tabulation software in top form. There was an inordinate amount of effort and planning involved in the online audition process this year, and all of the praise goes to Frank, Andrew and MusicFirst for their efforts to keep the process operating smoothly.

Be sure to visit with your Region Coordinators about issues you wish addressed at the State Board meeting coming up. Make your opinions about issues confronting ATSSB known to your representatives to the State Board so they can be discussed with a consensus from the membership.

Thanks to all of you for your continued diligence and hard work on behalf of the students in our small school programs during these stressful and unprecedented times. Keep up the great work.

President-Elect, Class 1C and Class 3A Representatives to the State Board of Directors will be elected by email the first week of January. If no candidate receives a majority of votes, the top two vote-recipients will be in a run-off to be held the first week of February (watch the website for details). Nominees who submitted a biography and/or picture by the time of publication follow below. Only current Retired and Active Members actively involved in 1C middle schools (including the high directors involved) may vote on 1C Representative. Only current Retired and Active Members actively involved in Class 3A high schools may vote on 3A Representative. All current Retired and Active Members may vote on President-Elect.

President-Elect

Rodney Bennett

is the director at Olney High School in Region 7. He is in his thirty-ninth year of teaching and thirteenth year as Director of Bands for Olney ISD. He previously held the same position at Palacios ISD for three years and was Director of Bands for



twenty-three years at Munday ISD.

Bennett holds Bachelor of Music and Music Education degrees from Midwestern State University in Wichita Falls and a Master of Music degree from Eastern New Mexico University.

Mr. Bennett currently serves as TMEA Region VII Band Chairman and served in this position for Region II from 1994-2005 and 2008-2014. He has also served in various capacities as Region and Area Honor Band host and Region, Area, and State Honor Band Judge. Bennett has also served as TMEA Region XIII Region Band Organizer and Region II North Zone A-AA-AAA District Band Chairman. He was also a TMEA clinician at the 1994 and 2000 conventions.

Mr. Bennett currently serves on the TMAA Marching Band Adjudication Sheet Revision Committee and is also a current member of the Olney ISD District Improvement Committee. He has served on several UIL committees, including the UIL State Marching Band Contest Revision Committee as the Class A Representative and the UIL Sight-reading Committee. He has served on the TMEA Honor Band Revision Committee and now serves as the Region VII Band Division representative to the UIL Music Advisory Committee. While at Munday, Mr. Bennett served as a member of the Munday High School Campus Improvement Team and on the Munday ISD District Improvement Committee.

Mr. Bennett is a member of Phi Beta Mu (Alpha Chapter) and served as a Member At-Large on the International Board from 2009-2017. He has also served on the International Bandmaster of the Year and Texas Young Bandmaster of the Year Selection Committees, and chaired the Outstanding Contributor and Constitutional Revision Committees. Bennett was a clinician as part of a panel presentation on successful small school band programs at the Midwest Clinic in 2000 and 2004, both sponsored by Phi Beta Mu. He also performs annually at the Texas Bandmasters Association Convention as part of the Phi Beta Mu Reading Band.

Bennett is a member of the Association of Texas Small School Bands (ATSSB) and served as Class A Representative on the State Board of Directors (1994-1996, 2001-2002). Bennett has also been nominated several times for President-elect of ATSSB and continues to serve as a judge for Region, Area, and All-State tryouts.

He a member of the Texas Music Adjudicators Association, Texas Music Educators Association, Texas Bandmasters Association, American School Band Directors Association, and the National Band Association. Since 1999, Mr. Bennett has

served as Director of Doc's Oil Bowl Band (Shriners All-Star football game), and is the only remaining charter member of the group (founded in 1974). Bennett is a life member of Kappa Kappa Psi and holds a Faculty Life membership in the Tri-M Music Honor Society. He is also a member of the Fellowship of Christian Musicians, previously serving as an advisor to the Munday High School Chapter and current sponsor of the Olney High School group.

Mr. Bennett and wife Marilyn were honored in February, 2019 by being named the first recipients of the Midwestern State University Music Department "Music Educators of the Year". Mr. Bennett was recently selected as one of "50 Directors Who Make a Difference" by School Band and Orchestra magazine and featured in the December, 2018 issue. He was elected to the John Philip Sousa Foundation Legion of Honor in 2013 and was also the recipient of the UIL Sponsor of Excellence Award in the same year. Bennett was named to the Who's Who in American Education (1996-1997, 2002-2003), Who's Who Among America's Teachers (1992, 1998, 2002, 2005), TMEA Class A Honor Band Director (1994, 2000), and was named Co-Citizen of the Year in 1993 by the Munday Chamber of Commerce and Agriculture. He was honored in 1994 and 2000 by the National Band Association with a Citation of Excellence. Mr. Bennett was a 1996 recipient of a Texas Music Educators Association Scholarship for Graduate Study.

Under his direction, Munday High School Bands received nineteen consecutive first divisions in marching, fifteen Sweepstakes Awards, 1994 and 2000 TMEA Class A Honor Bands, finalists in the ATSSB Outstanding Performance Series from 1997-2005 (first place awards in 1999 and 2000). The Purple Cloud Marching Band was a UIL State Marching Band participant nine times since 1987 and was selected as a finalist seven times from 1987-1999. State finalist bands in these years ranged from sixth place to two second-place

finishes. The Purple Cloud Band performed at the Centennial Parade to commemorate the centennial of the Capitol Building in Austin in 1988 as well as the re-dedication of the Capitol Building in 1995. Under his direction, the Munday High School Band served as a Texas representative to Washington, D.C. in 2004 as part of the ceremonies of the dedication of the World War II Veterans' Memorial during Memorial Day festivities. The Olney High School Band performed at the WWII Memorial in May, 2018 as part of the Memorial Day commemoration.

During his tenure at Palacios, the Fighting Sharks Band received the first UIL Sweepstakes Award in ten years. The PHS Band advanced to the Area E UIL Marching Contest, another first in a decade.

While in Olney, the band has received multiple Sweepstakes Awards and advanced to the Area Marching Contest in 2011, 2013, 2015, 2017, and 2018. The Olney HS Band gualified for the 2013 UIL State Marching Band Contest and was a 1A finalist. This marked the first time in 25 years that the Olney Band qualified for the UIL State Marching Band Contest. In 2015 the Olney HS Band was alternate to UIL State Marching Contest and participant in the 2017 SMBC. The band was also named a finalist in the 2015 TMEA Honor Band competition. The Pride of Olney has achieved nine Sweepstakes Awards, of which there have been eight consecutive honors (2012-2019).

Rodney is married to wife Marilyn (also a band director) for 40 years. Bennett has one son, Ronnie (lead minister – One Life Community Church) in Wichita Falls, Texas. Ronnie and wife Ashley have three children - Emma, Jude, and Ezra. Bennett is also a former member of the United States Marine Corps, member of the American Legion, and an avid railroad enthusiast.

"It is a great honor to be nominated for President Elect of ATSSB. I have been an active member of ATSSB since the founding

Angie Liss is the band director at Howe High School in Region 24. She is a graduate of Howe High School where she was a band member (flute) under the direction of Elmer Schenk. She attended Baylor University on a piano



scholarship for two years before transferring to Texas Woman's University where she graduated with honors with a degree in Music Therapy. She worked for 6 years as a music therapist in the Arlington and Allen Independent School Districts. During those years Mrs. Liss was very active as an accompanist for several DFW metroplex band and choir programs. She continues to serve as an accompanist, not only for her church, but also for many area band and choir students. This is her 27th year in the Howe ISD, starting there as an assistant band director under Elmer Schenk in the fall of 1994 before being named the head band director in the spring of 2005. During its 40+ year existence, Howe High School bands have been highly successful including 35 sweepstakes awards, 22 appearances at the state marching contest and numerous finalists and wins in the TMEA Honor Band and Outstanding Performance Series.

She and her husband, Andreas, live in Howe where they spend extra time working around the farm and at their church. They have four children and their spouses/significant others and one precious grandson, Jones, born this past July.

My experience on the executive board and as Region 24/25 coordinator as well as my 27 years as a Howe director provides a solid foundation for future decisions as we continually strive to be an organization that commands the utmost respect across the state, regardless of the size of our schools. My heart truly has a passion for students and I will always work to do all that I can to help foster their opportunities in music and support you as you work for your students as well. Thank you for your consideration on this year's ballot."
