Mr. Griffin noted that the procedure for reporting results of the state taping audition would be as follows: the state taping coordinator will fax the results to the Executive Secretary and all Area Coordinators who had a fax number, then call each Area Coordinator who did not have a fax number; the Area Coordinator will call or fax their Region Coordinators to report the names of students selected in each respective Region; the Region Coordinators will be responsible for contacting individual directors of students selected for the All-State Band in the taped auditions. Only Area Coordinators may call the State Taping Coordinator for results and only then if it is an unusually long time after the taped auditions are supposed to be completed. The complete standings will be mailed to each student in the taping process along with a letter of regret if they were not selected and a letter of congratulations and a Form 17T listing housing assignments to those students selected for the band.

Mr. Griffin showed a graphic detailing the design of this year's Area, High School All-Region and District, and Junior High All-Region and District patches. The patches each have the Association logo.

There being no further business, Mr. Pankratz adjourned the meeting at 8:36.

February. Elections will be held in the General Session - tentatively scheduled for Thursday, February 9, 1995, at 11:00 a.m. in the Scottish Rite Auditorium Banquet Hall.

In the Executive Secretary's report, Mr. Griffin announced that 163 members had paid dues to date out of the total of 596 registered at the end of last year, which was a good start on the year. He reported that the Association had been granted non-profit status by the post office and had received a bulk rate permit, saving hundreds of dollars in postage (\$85 to mail the July Newsletter as opposed to \$750 for first-class postage). It was also noted that the time line for mailing would have to be increased to insure the members received it early enough. The Prescribed Music List was mailed to every registered 1993-94 member with the July Newsletter. He reminded the membership that Jordan Sound Productions and Baylor University were producing tapes of the audition music. He reminded them that the enamel lapel pin was available for \$2 and the 10" All-State Band patch for students was available for \$8. He showed a graphic of the new patches for 1994-95 which have the Association logo on them. He went over All-State housing at the Ramada Emily Morgan.

In new business, Howard Galletly suggested that ATSSB become more involved in the selection of A, AA, and AAA honor bands. After a short dialogue, it was agreed that ATSSB would seek to be included in the selection of at least some of the judges on the panels. Mike Bendiksen added that he wished there were some way to separate the junior high honor band selection process so that junior highs that feed small school would not have to compete against junior highs that feed AAAA and AAAAA schools.

Don Stockton suggested that each region charge an all-region audition fee high enough to pay for students selected to Area so that fees need only be paid once.

Mr. Pankratz congratulated the new Region and Area Coordinators for getting involved and encouraged the membership to become more active not only at the region level, but also at Area and by running for state-elected offices. He thanked Mike Marsh for serving on the UIL Prescribed Music List Committee and reported to the membership that Dick Floyd, Bob Floyd, and Tom SoRelle were interested in continuing the involvement of ATSSB in their decisionmaking processes.

There being no further business, Mr. Pankratz adjourned the meeting at 2:37.

The State Board of Directors of the Association of Texas Small School Bands met for breakfast at 7:00 a.m. in the Travis room of the San Antonio Marriott Riverwalk.

Not present were Founding Charter Members Dwayne Bishop and Lonnie Dooley; Region I Coordinator Tim Youree; Region III Coordinator Darryl Trent; and Region XII Coordinator Craig Hunt.

After enjoying a continental breakfast, President Fred Pankratz called the meeting to order at 7:07 a.m. Louis Thornton gave the invocation.

The oath of office was administered to all new members of the board and reaffirmed by all returning members.

The minutes of the SBOD meeting July 30, 1993 were corrected by Jennifer Willison to show that Dr. Gary Garner was the conductor of the All-Region Band Director's Band, not the student's All-Region Band. The minutes were approved as corrected after a motion by Mike Bendiksen and a second by Jesse Lotspeich.

In the President's report, Mr. Pankratz gave out the handbooks to all officers which contained the rules and regulations for auditions, roster of members by region, forms to use for auditions, and a copy of the Prescribed Music List. He announced the appointment of Bryant Harris of Sundown to fill the unexpired term of Vice-President (John Gibson having left the profession). He mentioned the addition of waiver of liability on forms this coming year to absolve the Association of responsibility should students' personal effects be stolen while at the All-State Clinic (as three trumpets were stolen this past year which the Association replaced).

A reminder about piccolo and Eb clarinet: If your flute or clarinet player that made the All-State Band would like to play piccolo (flutes) or Eb Soprano Clarinet (clarinets), have them bring their piccs/effers to San Antonio. After regular chair auditions are completed for flute/ clarinet, we will hold separate auditions for these two instruments from among those students interested in it. Selection of piccolo or soprano clarinet has nothing to do with chair placement in the flute/ clarinet section

We plan to hold our ATSSB Business Session in the Scottish Rite Auditorium at 11:00 a.m. on Thursday, February 9. Elections for President, President-Elect, and Executive Secretary will be held at this meeting, so I hope you can make plans around the busy activities in San Antonio at that time of year to attend. By the way, you need to have your current ATSSB membership number ready. You will need it to vote. We will also be voting on some amendments to the Constitution (generally "housekeeping" changes), but the one that should benefit us most is changing the membership year to September 1 - August 31. The biggest problem I run into is providing memberships to you on the day region entries are due. I cannot issue a card without receiving payment of membership dues, so it gets rather "sticky" sometimes with region coordinators. I have probably faxed thirty or forty copies of membership cards this year! Perhaps with a September-August membership year, we can all remember to join early to avoid these kinds of problems in the future.

In the Executive Secretary's report, Mr. Griffin reported the continued availability of enamel lapel pins for the membership at \$2 each and the 10" all-state patch for \$8 each. He reported that a copy of the PML was sent to every registered member with the July NEWSLETTER and that the newly-acquired non-profit status with the post office allowed considerable savings in postage (comparing first class estimate of \$750 for the mailing to the \$85 that it actually cost). He reported the new Ramada Emily Morgan housing information being included in all packets that showed changes in the prepayment and checkin procedures.

The first item of business was a report of the upcoming constitution changes. The first was to change the membership year from the current July 1 - June 30 to September 1 - August 31. This was suggested to allow for the many changes in jobs that take place each year and to allow the schools' budget years to coincide with our Association's. The State Board voted unanimously to recommend this change after a motion by Don Stockton and a second by Dennis Teasdale. The second amendment more clearly defines the President's authority to name non-elected positions in the organization (Area Coordinators, State Taping Coordinator, All-State Band Organizer, All-State Percussion Organizer, and All-State Band Seating Auditions Coordinator) in addition to naming persons to fill unexpired elected terms. The State Board voted unanimously to recommend this change after a motion by Don Stockton and a second by Jennifer Willison.

The next item concerned reviewing and acting on recording bids. Only one bid was received to make the All-State Band recording - Educational Recording Service (John Hoover) in Ozona. The price per cassette tape was \$10.00 each. Proofs are to be sent to the Association President for approval. The bid was accepted unanimously after a motion by Jennifer Willison and a second by Jesse Lotspeich.

The next item was a report from the SARC (Seating Auditions Review Committee), chaired by the Vice-President. Bryant Harris reported that since he was new to the position, he knew of no recommendations from the committee. He had received a letter regarding scales but would refer it to the committee as a whole which would be meeting between now and February. Any member having suggestions regarding changes in the audition process were urged to contact him or any member of the committee (Ronnie Page, Richard Shanks, David Smith, George Strickland, and Dennis Teasdale).

The next agenda item was to consider making the PML a four-year rotating list. David Smith liked the economy of using one set of books. Jesse Lotspeich suggested using a five-year rotating list since some regions include eighth-graders at the region level. Don Stockton reported that his region overwhelmingly wanted to use two of the three TMEA etudes. Mike Bendiksen also wants to use TMEA etudes. Several regions reported pulling completely out of TMEA All-Region auditions because of the fees involved (most of which paid for the large school clinicians, etc.). It was mentioned that although the current TMEA Band Division Vice-President was very helpful and sympathetic to our needs, there was no guarantee that future officers would cooperate in giving the Association the etudes early enough to publish excerpts by TBA. Mike Marsh made a motion that we have a five-year rotating list to be selected by the SARC. After a second by Jesse Lotspeich, it was decided that the SARC would not only select a completely new set for 1995-96, but would also review the previous four sets to standardize length. range, etc. and would review and standardize the scale octaves. The motion passed with a vote of 23 for and 3 against.

The next item regarded the stipend voted for the position of Executive Secretary. The vote to pay a stipend included, at Mr. Griffin's request, a stipulation that the stipend would be reviewed in a year's time to make the SBOD aware of financial implications, leading to a lowering, raising or eliminating the stipend. Don Stockton moved that the stipend be raised to \$500 a month. After a second by Mike Bendiksen, the motion passed unanimously.

Mr. Pankratz reported the difficulty of using Yamaha percussion equipment at the All-State Clinic and of discussion held with Ludwig which reflected a similar result. He asked for ideas on how to provide percussion - from using only percussion from area schools to requiring that percussionists bring all of their own equipment (timpani, xylophone, orchestra bells, snare drums, etc.) and finding local bass drums and unusual items required by the music.

Region reports then were heard:

- II Suggested sending a certificate to principals of students in All-State for presentation at award ceremonies. Mr. Griffin stated that he would see to it.

Change ARTICLE V, SECTION 2 of the Constitution

from: THE PRESIDENT-ELECT. The President-Elect shall assume office in the manner prescribed in the By-Laws. The President-Elect shall be concurrently employed as a director or assistant director in a A, AA or AAA high school in Texas. The President-Elect shall be in charge of formulating, editing, printing, and distributing the ATSSB Newsletter, the official publication of the Association.

to: THE PRESIDENT-ELECT. The President-Elect shall assume office in the manner prescribed in the By-Laws. The President-Elect shall be concurrently employed as a director or assistant director in **an** A, AA or AAA high school in Texas. **The President-Elect shall be chairman of the State Audition Review Committee.**

Change ARTICLE II, SECTION 1.(a) of the By-Laws

from: DUTIES OF THE PRESIDENT. The President shall be the presiding officer of ATSSB meetings and of the State Board of Directors. He shall appoint members to committees and shall represent ATSSB, or appoint an alternate in his place, at meetings deemed relevant to the welfare of ATSSB. He shall be responsible for the overall program at the Convention-Clinic at the discretion of the State Board of Directors and shall perform all other duties pertaining to the office. He may appoint a Parliamentarian as needed and shall be an ex-officio member of all committees.

to: DUTIES OF THE PRESIDENT. The President shall be the presiding officer of ATSSB meetings and of the State Board of Directors. He shall appoint Area Coordinators, the State Taping Coordinator, the All-State Band Organizer, the All-State Band Percussion Organizer, and the All-State Band Seating Audition Coordinator. He shall also appoint members to committees and shall represent ATSSB, or appoint an alternate in his place, at meetings deemed relevant to the welfare of ATSSB. He shall be responsible for the overall program at the Convention-Clinic at the discretion of the State Board of Directors and shall perform all other duties pertaining to the office. He may appoint a Parliamentarian as needed and shall be an exofficio member of all committees.

Minutes of the ATSSB Business Session 2:00 p.m., July 26, 1994 Room 101, San Antonio Convention Center

The meeting was called to order by President Fred Pankratz with a full room and several standing against the walls. Louis Thornton gave the invocation.

Mr. Pankratz introduced Bryant Harris who he had appointed to fill the unexpired term of Vice-President (John Gibson having left the profession), Class AAA State Board Representative Ben Hoaldridge, Class AA State Board Representative Elmer Schenk, Class A State Board Representative Rodney Bennett, and Executive Secretary Kenneth Griffin.

The minutes were approved as printed in the July Newsletter on a motion by Mike Bendiksen and a second by Harold Bufe.

The financial report was approved as printed in the July Newsletter on a motion by Don Stockton and a second by Harold Bufe.

Mr. Pankratz reported on action taken by the State Board of Directors (see minutes elsewhere in this Newsletter).

No changes were made in the audition process, but members were urged to voice their opinions or suggestions to the State Auditions Review Committee and Chairman Bryant Harris or any of its members - Ronnie Page, Richard Shanks, David Smith, George Strickland, and Dennis Teasdale. The Prescribed Music List will become a five-year rotating list beginning in 1996-97. The SARC will select a new set of etudes for 1995-96 and review the other four sets to standardize the etudes in length, range, etc. and review the octave requirements for scales.

Percussion equipment for the All-State Clinic was reported to be a problem. Suggestions from the membership for addressing this problem were solicited by Mr. Pankratz.

Mr. Pankratz then reminded the membership about the nomination/election process for President, President-Elect (who will constitutionally assume the office of President after two years) and Executive Secretary. Nominations will be made at the Fall Region meetings. The nominations are to be reported to the Executive Secretary who will contact the nominees for verification of acceptance and to request a biography for publication in the Newsletter before

The band program at Overton has grown from an average size of 50 - 60 members to the present 88 students while maintaining superior ratings in UIL Contests. Overton students earned 6% of the 1993 ATSSB Region band chairs and 7% this year despite being a class A school. The band was a 1993 TMEA honor band finalist, and has just earned the fifth consecutive first division at UIL marching contest. They will be striving for their fifth consecutive UILSweepstakes this spring. Ronnie has served as Region XXI Coordinator since the inception of ATSSB, giving up that position this year to serve as the All-State Chair Audition Coordinator. He organized the selection of two complete high school and two complete

Change ARTICLE II, SECTION 2.(a) of the By-Laws from: DUTIES OF THE PRESIDENT-ELECT. The President-Elect shall preside at ATSSB meetings and at meetings of the State Board of Directors in the absence of the President. He shall appoint special committees necessary to the operation of his duties and shall be responsible for overseeing the preparation, editing and distribution of the ATSSB Newsletter, the official publication of the Association.

to: DUTIES OF THE PRESIDENT-ELECT. The President-Elect shall preside at ATSSB meetings and at meetings of the State Board of Directors in the absence of the President. He shall appoint special committees necessary to the operation of his duties and shall be **chairman of the State Audition Review Committee which is charged with the continuous review of the 5-year rotating Prescribed Music List.**

Add to ARTICLE II, SECTION 3(a) of the By-Laws **The Executive Secretary shall be responsible for the formulation, editing, printing, and distribution of the ATSSB Newsletter.**

Rationale: Needed to "fine-tune" wording in the Constitution and By-Laws to reflect policies already in effect.

Change ARTICLE I, SECTION 5 of the By-Laws from: THE MEMBERSHIP YEAR shall be July 1 through June 30. to: THE MEMBERSHIP YEAR shall be **September 1 through August 31.**

Rationale: Because of numerous changes in personnel across the state, it would be more practical to begin the membership year September 1 to coincide with current academic year budgets.
