I know that most of you are actively engaged in a flurry of spring activities at this time. Preparation for UIL contests, festivals, a myriad of performances and musical obligations left and right, trip plans, TSSEC - even getting a head start on next year by selecting music, planning drills, recruiting incoming bandsmen ----- and all of that in addition to family, friends and church activities!

Be sure to attend your spring region meetings. A proposal to change snare drum etudes is being studied by the individual regions for possible adoption by the State Board. Look over the proposal and make your opinion known so your Region Coordinator can vote your wishes when the matter is considered.

Interesting fact about the 2005 All-State Bands: The membership included 11 freshmen, 47 sophomores, 89 juniors, and 113 seniors.

HOUSING - Rami Purdum did a great job as the Floor Monitor Coordinator this year. Organizing the hotel checkin and making sure the kids were safe in the hotel is very important to small-school band directors. We had very few problems

with students this year. All directors with students in All-State need to continue to strongly emphasize the Code of Conduct and warn of the consequences even an innocent moment could have on their reputations or even their academic standing in their school should they break it. It would also help if directors kept a closer watch on their all-staters during the clinic but especially at night. Our Floor Monitors are there to insure the students' safety - not be disciplinarians (the Executive Committee has to take care of infractions of the Code). Please continue to help us in the future.

ORGANIZERS - Bing Bingham had to overcome a host of scheduling difficulties at the last minute to make sure there were adequate rooms for the State Chair Auditions. It is no small task assembling all of those panels of volunteer judges and securing stands and screens and the forms and pencils necessary and the computers and printers. Thanks again, Bing, for all of your hard work. And thanks to all of the directors who volunteered their time to sit on judging panels, monitor, run errands, etc., to make the auditions run smoothly. William Foster and Bruce Kenner (and apprentice Band Organizer David De Luca) had to give up most of their convention to serve as Band Organizers as did Bobby Fife, Brad Long, Travis Fife, and Ray Schneider as Percussion Organizers.

Interesting facts about the 2005 All-State Bands: Argyle and Midland Greenwood had 8 students make All-State; Celina had 7; Brownfield and Kountze each had 6; Lindale and Raymondville each had 5; Eight schools had 4. Thirteen schools had 3 students make All-State. Twenty-seven schools had 2 students and ninety other schools had 1 student make All-State. In all, 145 different schools were represented in the ATSSB All-State Bands (same as last year).

OPS - The **Outstanding Performance Series** was once again a great success in 2004 and the beautiful award the winners received in the General Session on Thursday is an enviable trophy to be seen in band halls across the state. The runner-up plaque was beautiful also, befitting the great honor these bands received from their peers. Congratulations to the winners and runners-up. I look forward to this year's competition and hope many of you enter your band's performance(s) from a contest this year. Don Thoede, OPS State Chair, will tell you more about the 2005 OPS elsewhere in the Newsletter. Be sure to read his article carsfully, as many changes have been made.

DIRECTORY - An ATSSB **Membership Directory** is available on the Website (http://www.atssb.org/ execsec/Directory.asp). You can view it (it is arranged alphabetically) or copy and paste all of the information into an Excel spreadsheet so you can use the data as you see fit. Since the State Board has voted that the ATSSB Website is the official document, we nolonger print the Directory (or anything else for mailout). All documents must be viewed/printed/downloaded from the Website in the future.

Interesting facts about the 2005 All-State Band: The band had 119 females and 141 males.

DUES INCREASE - The State Board recently voted to increase dues beginning with the 2005-06 year to \$35. The \$25 late fee is the same, so if you join after October 1, the dues increase to \$60 (with the \$25 late fee going to the Scholarship Fund).

APPLICATION - There is a **Membership Application** in this Newsletter and on the Website that you can download and use or give to your assistants or to share with neighbors. Membership renewal reminders will not be sent this summer, so use the one available online or linked here to join as soon as you can in the new budget

year (although we surely do appreciate all of the scholarship contributions you make when you join after October 1!). There is also a College Division Membership application available here and online. Give one to your senior bandsmen that might be considering music as a major or minor in college.

PAL - The Prescribed Audition List includes all known (and SARC-approved) errata to date on each of the etude pages. Be sure you are using the current data from the Website since an Update will not be mailed or passed out at TBA like we usually do (remember that the Website is the official document). We will be using YEAR E in the PAL for auditions in 2005-06. Watch the Website for the Year E Update.

Interesting facts about the 2005 All-State Bands: Of the 260 students in the bands, 13 were from class A schools (5.00% of the bands), 81 from class AA schools (31.15%), and 166 from class AAA schools (63.85%), all representing 145 different schools.

The **recording** of the All-State concerts is available on compact disc. You may still order plaques and t-shirts from the event. Use the order forms here or online to get yours today.

Use your contacts at colleges and universities across Texas (and beyond) to make sure that they give scholarships (all expenses paid) to ATSSB All-State students and tuition scholarships to ATSSB Area students for their **summer band camps** like some colleges do. Check out what the camp offers and then encourage your students to go where they are wanted. Several colleges have already contacted me wanting the All-State list so our students can be contacted about scholarship opportunities. More and more colleges are interested in our seniors each year. As you learn of colleges that provide scholarships for our All-State students, let me know so I can inform the membership.

Interesting facts about the 2005 All-State Bands: Of the 260 members, each of the 20 regions had an average of 13 students in the band. One region had 29 (the most) and one region had one (the least).

Please let me know if you need to **replace a Region Coordinator** in your Spring Meeting because yours moved, etc. I need to have their name as soon as possible for our plans for 2005-06 (call me at 713-874-1151 and leave a message). Your Region Coordinator is your region's representative on the State Board of Directors which makes all of the decisions for you regarding ATSSB matters. Make sure he/she or a proxy attends each SBOD meeting. It would also be nice if each Region Coordinator brought a mandate of opinion from region members so votes could be representative of each region of the state.

ATSSB gave \$28,000 in scholarships this year. Aaron Boone from Kountze, Tiffany Bridgers from Brownfield, Melissa Dale from Rains, Valerie Estes from Midland Greenwood, Mitchell Fuqua from Celina, Lauren Gillespie from Liberty Hill, Daniel Phillips from Wills Point, David J. Scott from Robinson, and Scott Tarver from Celina each received the **\$2000 ATSSB All-State Band Scholarship for making the band for four consecutive years**. Josh Cordero from Raymondville, Mandy Cruz from Denver City, Araceli A. Garcia from Lytle, Cindy Hinojosa from Argyle, Tiffany Langley from Overton, William Noth from Ranger, Juan Carlos Orozco from Muleshoe, Christine Philip from La Feria, Mark Stelzel from East Bernard, and Jeanette Wiemers from Hondo each were seniors that received the **\$500 ATSSB All-State Band Scholarship for making the band for three years**. All of these students were given a plaque in a brief ceremony during the concert. This makes forty-four students who have received the four-year scholarship and forty-seven who have received the three-year scholarship (this is the third year for the three-year scholarship to be given).

The large **10" ATSSB All-State Band patches** for the All-State Band members are still available should your student have neglected to purchase one at state. Send \$10 for each 10" patch to: ATSSB; 2117 Morse Street; Houston, TX 77019. Be sure to enclose name and address where you want them sent. We no longer have **OPS CD sets** available. You must order these from a secondary vendor as long as the limited supply holds out (that order form is also available here and online). Please be aware that we will no longer produce OPS CDs for sale. we will produce CDs in sufficient quantities to send one free CD to each eligible ATSSB school in Texas in September of each year. The State Board felt that this reference CD should be in every band hall in Texas.

Interesting facts about the 2005 ATSSB All-State Band: Over the last fourteen years, 2,786 students have been awarded All-State honors by ATSSB. Crane has had the most in All-State (73) -- they were Class AAA for many years, reassigned to Class AA recently -- followed by Brownfield (69) in Class AAA. In Class AA, Eldorado has had 21 and Canadian has had 19. In Class A, Overton has had 19.

My thanks to all of you for what you have done to make ATSSB what it is today.

Outstanding Performance Series

Some very important changes to the 2005 OPS competition have been made due to action taken by the ATSSB SBOD. Directors who plan to enter the OPS competition in May should read this article very carefully!

Directors will still mail the CDs directly to the **Designated Region Coordinator** on or before **May 20th**, just like they did last year, but the Designated Region Coordinator will be not be the same. Band directors are to mail the CDs to the following Region Coordinators (also called the **Designated Region Coordinators**).

Region 1 directors will mail CDs to the Region 21 Coordinator (Michael Miller; Route 5, Box 2734; Rusk, TX 75785; 903-683-2884). Region 13 directors will mail CDs to the Region 10 Coordinator (Evan Richardson; P.O. Box 1561, 708 Italy Road; Hemphill, TX 75948; 409-787-1526). Region 17/19 directors will mail CDs to the Region 22 director (Mike Porras; 10308 Bush Lane; El Paso, TX 79925; 915-590-8943). Region 22 directors will mail CDs to the Region 17/19 Coordinator (James Butler; 26134 Richards Road; Spring, TX 77386; 281-362-7382).

The Designated Region Coordinators will then collect all of the CDs that were mailed from the directors and will hire a panel (s) of adjudicators to judge the CDs. (just like they did last year). After the adjudication, the Designated Region Coordinators will mail their CDs to the following **Area Coordinators** (also called the **Designated Area Coordinators**) on or before **June 12**th (same as last year).

The Designated Region Coordinators of Regions 1, 6, 13, 16 will send their CDs to the Designated Area Central Coordinator (Bob Vetter, 1007 Virginia Circle, Big Lake, TX 76932, 325-884-3173). The Designated Region Coordinators of Regions 2, 3/20, 5/24, 17/19 will send their CDs to the Designated Area South Coordinator (Eric Winterbottom, 223 CR 373, Sandia, TX 78383, 361-547-2101). The Designated Region Coordinators of Regions 4, 21, 9/23, 11 will send their CDs to the Designated Area West Coordinator (Jimmie Exline, 6521 88th Street, Lubbock, TX 79424). The Designated Region Coordinators of Regions 7, 8, 10, 15 will send their CDs to the Designated Area North Coordinator (Greg Miller, 712 West Clara, Iowa Park, TX 76367, 940-592-9788). The Designated Region Coordinators of Regions 12, 14, 18, 22 will send their CDs to the Designated Area East Coordinator (Danny Burns, 525 Pecos Drive, Chandler, TX 75758, 903-849-3579).

In addition to the above changes for the 2005 OPS competition, the SBOD also approved the following. TMEA active members may serve as OPS judges only after the Designated Region and Designated Area Coordinators have exhausted all attempts to secure active ATSSB members as judges. Please use non-ATSSB members as judges only

if absolutely necessary and be certain that they are active TMEA members!

This last item is a requirement of all five Area Coordinators. Each Area Coordinator will not begin Area auditions until communication has taken place between the Area Coordinator and the four Region Coordinators that mailed advancing CDs to Area. For example, the Region Coordinators from Regions 1, 6, 13, and 16 are supposed to mail their CDs to the Area Central Coordinator (Bob Vetter). Bob needs to be certain that the advancing CDs from those four Regions are in his possession, or accounted for, before he begins the Area auditions.

As the State Chair, I feel the need to keep telling the membership that most every problem that has arisen with OPS is the result of the lack of communication between members. If any of the mailing addresses, phone numbers, etc., listed above are incorrect, you should contact me immediately. Kenneth Griffin and the Region and Area Coordinators need to be contacted also.

Mr. Lowes introduced TMEA President **Mike Ware**. Mr. Ware gave words of welcome to ATSSB from TMEA.

For the office of TMEA President-Elect, Robert Stoval spoke for Joe Miller and Kim Reedy spoke for Dr. Alexander.

Kenneth Griffin explained how ballots were to be marked when time came to cast them.

Mr. Lowes then introduced candidates for the office of Class C/CC Representative and asked if there were any nominations from the floor. Hearing none, he asked for speakers for candidates for the office. Rodney Bennett spoke for Marilyn Bennett, Rob Toups spoke for Ben Davis, Eric Gray spoke for Sherry Poteet, and Dale Stelzer spoke for himself for the office of Class C/CC Representative.

Mr. Lowes then introduced the candidates for the office of Class AA Representative and asked if there were any nominations from the floor. Hearing none, he asked for speakers for the office. John Canfield spoke for Gehrig Blankenship, Shane Goforth spoke for himself, Ray Sanders spoke for Carl Idlebird, and Ray Vasquez spoke for David Rollins.

Heard reports of **Standing Committees**:

President-Elect and SARC Chair Steven Moore thanked his committee members for their work and reported State Audition Review Committee motions:

Noted that a box had been added to the **online jazz entry** to designate **Region Only** or **Area/State Track**.

Clarifying jazz audition music selection process:

1) "Music submitted to State Jazz Coordinator in January; Committee appointed by Jazz Coordinator to meet at TMEA to review the music for errors and minor corrections with recommendations submitted to composer the week after TMEA; Jazz audition music and CD available for delivery April 1."

2) Add to Jazz **Form 8** for Region Coordinator signature: "I certify that all CDs submitted have been listened to and have been recorded with the CD accompaniment."

3) Add the following statements to the **Jazz Audition Procedures** in section **IB** in the PAL: "If the performance is not recorded with CD accompaniment, the performer will be disqualified and the entry fee will not be returned."

4) Add the following statements to the **Rhythm and Wind Section Jazz Audition Instruction Sheets**: "a. All students will be recorded with the accompaniment CD or their audition CD will be disqualified. b. You may not use any pre-written solos for the improvisation section of this audition."

5) Encourage each region to submit names of directors willing to **judge the State Jazz auditions**. It is also suggested that the regions help defray the

expenses of those directors from their region who judge.

Motion by committee, second by Brandon Brewer. Motion carried unanimously.

Revise the jazz audition process in the PAL to read as follows: IB. Change "Region recording guidelines" to "State Recording Guidelines: All audition CDs will be recorded under the supervision of the Region Coordinator or designee. All audition CDs will be

recorded at one Region recording session. All Regions are urged to follow the All-State Jazz Ensemble Recording Recommendations." Motion by committee, second by Bobby Vetter. Motion passed unanimously.

Add to Section IIIB of the Audition Procedures: "Students will report to a Warmup/ Holding Room that is near their audition room. and then be sequestered for the duration of the audition process. Students will be released one at time to audition then return. After the second round, they are dismissed from the Warmup/Holding Room. Students may not leave the room unless excused for bathroom or water breaks by the Room Monitor." Motion by committee, second by Victoria Young. Motion failed. John Odom moved that the Area Coordinators meet as a committee to study the need for a designated holding/warmup room and report to the SBOD at TBA. Second by Gary Robbins. Motion passed.

Amend Section IB of the Additional Procedures and Rules for Area Auditions: "If an originally certified student becomes unable to attend the auditions (because of illness, academic ineligibility, etc.), it shall be the responsibility of the Region Coordinator of the student that is a DNA to certify a new candidate from the same region to the Area Coordinator." Motion by committee, second by Mike Barnes. Motion carried.

Add to Year D Clarinet errata: "P. 56, No. 10. The 11th note of measure 9 should be a D natural. Also, the 1st note in measure 21 should be an A flat (the flat is omitted in earlier editions." Motion by committee, second by Daniel Aleman. Motion carried.

The SARC recommended that Region Coordinators take a proposal regarding new snare drum etudes home to the membership to decide its merit, and then bring a consensus to the July SBOD for possible adoption. The proposed etudes will be sent to all Region Coordinators for distribution and study at the May region meetings.

Immediate Past-President Gary Robbins noted that there was no report from the Past-President Committee. In the **OPS Report** by Don Thoede, he noted that OPS entries must be sent to new Designated Region and Area Coordinators this year and urged everyone to be careful to follow all published directives in the process this year and that all data would be on the website.

on improving the system, Brandon Brewer moved and Mike Barnes seconded that a **late fee of \$100** per school be charged to schools that miss the deadline for securing a room at the Emily Morgan. Motion passed.

Kenneth Griffin reported that the TMEA/ATSSB Dialogue Committee dealt with ATSSB's request that the ATSSB President be involved in initial discussions the TMEA Presidents' Committee has regarding an ATSSB appeal and that the wording of the ATSSB Appeals process would have to be so amended.
