V. Deadlines and Dates

- A. OPS deadline is May 18th
- B. Entries are not accepted without current ATSSB and TMEA active membership numbers.
- C. All contest deadlines will be 14 days prior to the audition
- D. The late and final online student entry will be 7 days prior to the day of the audition.
- E. Corrections to an existing student may be made between 13 and 7 days prior to the audition without penalty, but any student entry added less than 14 days but more than 7 days prior to the contest will result in an additional 100% student late fee.
- F. Entries begun less than 14 days but more than 7 days prior to the contest will be assessed a 100% additional student late fee charge.

- G. A *CAMPUS* entry created less than 14 days prior to the contest will be subject to the **TMEA Grievance Process**.
- H. Directors will be allowed to add or change student entries on the day of the audition if region rules allow it. A 100% additional student late fee will be assessed.
- I. All fees must be paid prior to the start of the auditions.
- J. Please note that the TMEA online entry process includes a 3A and 4A All-State Track All students in Class 1A, 2A, and 3A are automatically in the 3A Track and all students in Class 4A are automatically in the 4A Track unless they submit a Track Selection with their initial entry selecting another track or TMEA 5A or 6A Track. Students may only change to a larger school track, not a smaller one.
- K. HS & MS All-Region entry deadlines (using the TMEA website):
 - 1. HS Jazz tryout August 25th, 2024
 - 2. West Zone MS tryout November 22nd, 2024
 - 3. East Zone MS tryout November 23rd, 2024
 - 4. HS tryout November 30th, 2024
- L. You may bring entry fees on the day of auditions (PREFERABLE) or mail entry fees. It is your responsibility to ensure all fees are in BEFORE the audition. Choose accordingly.

M. Make sure that the head director of the school entering is the one entering students. **Enter all directors - assistants, middle school directors, etc.**Check Spelling and capitalization carefully while entering students – this data is transferred to programs, and archives and given to colleges requesting it for scholarship considerations. There will be no late entries or corrections after the entry deadline. Please be aware that the ATSSB State Board of Directors amended the official STUDENT ENTRY AND REGISTRATION PROCEDURES as follows:

"Each student's director (or a qualified proxy) MUST attend and be available to adjudicate the auditions. Directors who are found to be in violation of judging, student entry, or fee payment requirements will receive one warning from the Region/Area Coordinator. After this warning, the issue will be escalated resulting in contacting district administration and potential removal/probation of that director's student entry ability (a district appointed administrator other than the director in question will be allowed to enter students and ensure judging requirements are met)."

- N. Audition material, scales required, octaves required at the region level recording. This may not be changed after September 1st for the coming audition cycle. Cuts may be made at the auditions, but etudes may not be lengthened or changed after that date.
 - HS Audition Material No known errata other than that printed in PAL online
 - 2. MS Audition Material is available on the ATSSB Region 6 website. Please do not use the ATSSB adopted list that is provided for the state. We use our own set of etudes.
 - 3. <u>Jazz Audition Materials</u> are bought from Mattei music services and the link can be found on the ATSSB website. There are no updates to the Year D set so if you have the music from 2019-20, you're safe to use that music.

Note: you must be registered for TMEA and ATSSB to sign students up for the audition. Audition sign up deadline for jazz is on August 25th and many school budgets don't open until Sept. 1. Plan accordingly to be sure you are a registered member of both TMEA and ATSSB before the sign up deadline.



- 2. Area tryouts will be held at Levelland HS on January 11th, 2025. Area fees are \$25. We are Area B West (New process for paying area fees. **Pay to Region 6** and we will write check to area)

- 5. Be aware of housing procedures at All-State (Hyatt Regency) and that **students must bring a wire stand to state**

6. Note that at All-State Chair auditions, no electronic devices shall be allowed in the audition room other than tuners and metronomes (no cell phones or mp3 players or iPods - if found, these will be taken up until after auditions); however, students may use electronic media in lieu of printed music (a book is still provided on the stand for student use) so long as the media does not conflict with the existing rules governing electronic devices as listed above.

- 7. Starting in 2021 TMEA decided to do all state chair auditions virtually. ATSSB considered making this change last year and this year. Both years we decided at the state board meeting at TBA to keep our auditions the same and have them in person the way they have always been.
- VI. **OPS entries** ***Please remember that the director of the band must be an ATSSB member. If you are directing a Non-Varsity Band, be certain you're a

member of ATSSB before entering! **NEW FOR THIS YEAR ATSSB** has decided to pilot Non Varsity classifications for OPS at both the high school and middle school level. During the pilot there will be one Non Varsity track for all classifications at both the high school and middle school level. https://www.atssb.org/ops/

VIII. Rules

- A. Eligibility students must be eligible to try out for any of the organizations, and they must be eligible for the clinic/concert. No pass, no play applies to ATSSB and TMEA.
- B. Instrumentation accepted per band This is set and in the Region Rules & Procedures on the website.
- C. Judging requirements if entering students: every director from that school (middle school and high school) is expected to be at the audition or have a proxy in their place. If you must miss, please, submit a name to the region coordinator for approval ASAP.
 Reminder there is a rule that no pictures may be taken nor any audio or video recordings made in the room(s) where judges' scores are displayed for directors to check.
- IX. Jazz recordings for Area Jazz Adjudications must use the backing tracks available online for each region. Those only contain the accompaniment tracks to minimize disqualifications. Contact Brian Donnell if you need access to that file. Follow the instructions on the TMEA instruction page found at https://www.tmea.org/regions/chair-resources/tabulation-help/?Chapter=70
- X. **Note about audition process** This will be the 3rd year that we use the new system for score entry. Due to the changes in the audition software, you will no longer need to wait for the all-clear to enter scores and SHOULD begin entering

scores immediately. This should help make auditions move even quicker at the beginning. Directors may also judge on paper during the audition as a backup. Be certain to bring a device to enter scores on.

- XV. **UIL** UIL information will be presented in the 1:00 meeting. A few quick items:
 - A. UIL C/SR Evaluation Reminder that no pass/no play is gone, BUT it's up to your school's administration to decide if they want to follow that or continue using it. BE CERTAIN to ask your admin about this.
 - B. ORIGINAL SCORES for all 3 of your pieces for all 3 judges. You need 3 original scores of all 3 pieces for the judges.
 - C. The UIL Report at the ATSSB state board meeting by the UIL Assistant music director, Gabe Musella, included the following:
 - 1. The pilot sight reading process will be for all regions next year.
 - D. Section 1105: REGION MARCHING BAND CONTEST (d) DIRECTOR'S COMPLIANCE STATEMENT. Each entry in the region marching band contest shall be accompanied by the following statement signed by the director and school principal. (1) "The members of this marching band or any of its components did not begin preparation of the visual curriculum for this UIL contest presentation prior to August 1. In addition, no more than 15 hours of supervised instructional time was devoted to visual fundamentals between the end of the previous school term and August 1." Exception: Auxiliary camps, leadership training and preparation for special summer events such as civic parades, professional football game appearances and other non-competitive performances are not considered a violation of this limitation.

- E. Marching Band Physicals A reminder to have all of your kids have their physicals completed before you start August 1. It continues to be the requirement and students must have a new physical at the beginning of their freshmen and junior years. A reminder that a medical history form is due every year. If a student answers yes to questions 1, 2, 3, 4, 5, or 6 then they will require further evaluation which may include a physical examination.
- F. Marching band safety training Be sure everyone on staff has completed this training.
- G. CPR/AED training Be sure everyone on staff is certified
- H. 8 Hour Rule forms

XVI. New Business

- A. There are times in the year when there is over \$5,000 in outstanding checks to the region, and times when we have to reissue lost checks. Additionally, when there are auditions or events I cannot be at due to West Zone, I have to send over a few thousand dollars in checks. Having an electronic payment system for the region would help with this. This would also make donations to the scholarship fund easier for concert attendees. Venmo comes to mind, but I am open to suggestions.
